Employment

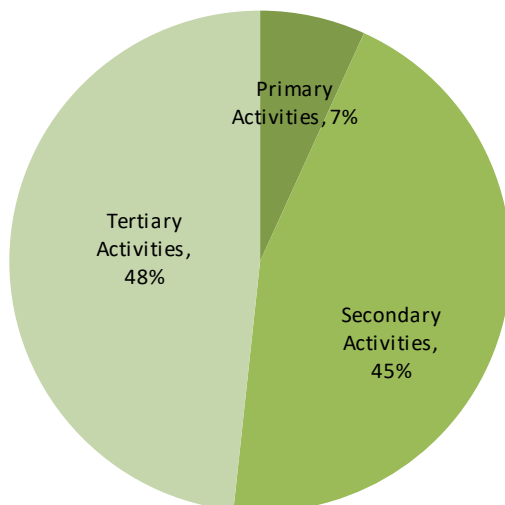
Sonora recorded 1.3 million workers during 2016, mainly in commerce and manufacturing. In respect to the national level, the state represented 2.4% of the workers in commerce and 2.7% in the manufacturing industry.

Economy

The Gross Domestic Product (GDP) of Sonora reached 507 billion pesos in 2015, and contributed 3.0% to Mexico's national GDP.

Tertiary sector, which includes trade and real estate services, contributed 48 of the state's GDP in 2015.

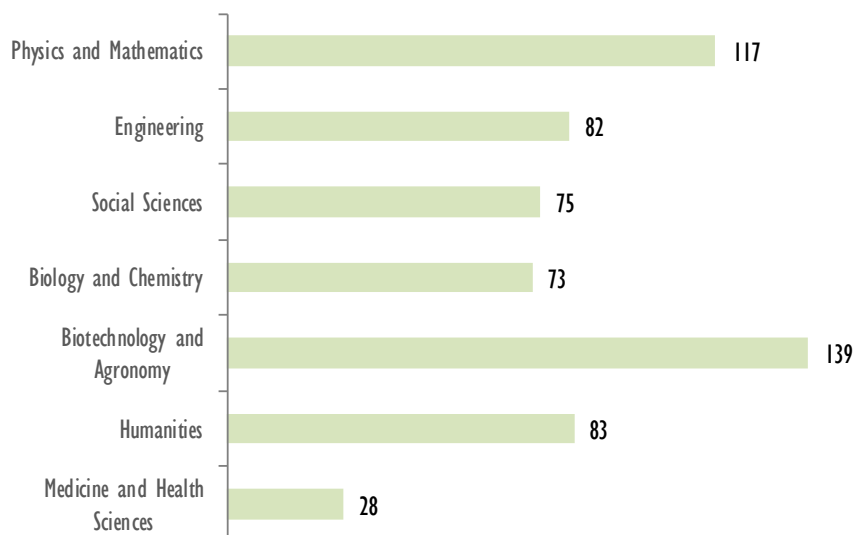
